1. Introduction

This report is presents the findings of the different consultations that have taken place to develop and validate the national ICT in education policy. It is the fifth deliverable in an overall assignment to support the development of a national ICT policy and strategy for basic education in Suriname.

The assignment is being carried out by International Institute of Communication and Development (IICD, The Hague, the Netherlands) for the Ministry of Education and Community Development (MOECD) in Suriname, under the 2nd Basic Education Improvement Program (2nd BEIP). Sub-contractors are Free man management consultants (Ooij, the Netherlands), Edukans (Amersfoort, the Netherlands) and Projekta (Paramaribo, Suriname).

The main objective of this report is to provide account for the different consultations that have taken place both at national and regional level. The report consist of a collection of links to reports of the different meetings and to video interviews that have taken place during the consultation and validation process for the National ICT in Education Policy.

2 Consultation process

2.1 Kick off meeting

The development process of national ICT in education policy started with a kick off meeting on the 11th July 2013 in Krasnapolski Hotel in Paramaribo with an opening by Minister Adhin. During the Kick off meeting a quick scan was conducted with the various stakeholders to make an inventarization of the stakeholders, an overview of existing situation of ICT in Suriname including some good practices, key challenges and preconditions for integration of ICT in education and the priorities according to the stakeholders.
